6. Any restrictions imposed by Corona will be announced in good time



### Liability Disclaimer and Declaration of Consent

To take part in the private event 50-th Anniversary Grumman Fly-In August 21-23, 2020 in EDKB / Bonn Hangelar, organized by Kathrin Kaiser, hereinafter referred to as "organizer" - it is necessary that you - hereinafter also "participants" called - read the following conditions carefully, observe them, confirm by submitting the registration form that you have read them: By submitting the registration form you recognize the conditions listed here as acknowledged.

The organizer points out that participation in the event involves dangers and the risk of serious injuries, including permanent damage to health, including fatal accidents and damage to property cannot be excluded. It is also pointed out that this is an event - that is potentially dangerous, - that takes place outdoors, - that is also carried out in bad weather and / or in bad light. The organizer is not liable if and insofar as the participant violates the instructions of the organizer or a vicarious agent. The participant assumes full liability for damage caused by deliberate or grossly negligent fault on the part of the participant (in particular due to improper handling of the organizer's equipment) or if the instructions of the organizer or his staff are not followed.

The organizer has unlimited liability for damage caused by the organizer, provided the cause of the damage is based on intent or gross negligence. Participation is at your own risk. The organizer assumes no liability for the health risks of the participant in connection with the participation in the event. It is the responsibility of the participant to check his state of health beforehand, if necessary to have it checked by a specialist. The organizer is not liable for injuries caused by other participants or outside third parties. The organizer assumes no liability for objects stored by the participant; the liability of the organizer due to gross negligence on the part of the third party he has entrusted with the retention remains unaffected.

Final provisions (1) Should a provision of this exemption from liability and declaration of consent be or become ineffective in whole or in part, the effectiveness of the remaining provisions remains unaffected. (2) Place of jurisdiction is Bonn,

By submitting the registration form, I finally declare that I have read this exemption from liability and declaration of consent carefully and in detail, that I understand the content and that I expressly consent to its content.
